Remarks from the CEO:


This past year, we stood at the intersection of hope and hustle. We've seen the faces of young men and women transformed through the power of sport, mentorship, and community. We've been in the gymnasiums, on the sidelines, and in school hallways, not just coaching, but cultivating leaders.


This past year has also been a transformative season for Chosen Sports Leagues. Our mission to provide high-quality sports and mentorship programming has continued to flourish, with player enrollment growing to 237 athletes for Season 2 (April–June 1).

And we haven't done it alone.

We're excited to announce the upcoming launch of our High School Preparation Summer League, designed to develop and showcase local boys and girls basketball talent during the off-season. This initiative is being built in partnership with Liberty High School and will serve as a feeder system into high school programs, creating visibility and growth opportunities for student-athletes.

Our Pathway Player Program, a cornerstone of our mentorship efforts, is now officially under contract with the Liberty Union High School District, with negotiations underway to extend services into Mt. Diablo Unified School District. This expansion will allow us to provide behavioral and academic support through sports-based mentorship at scale, aligning directly with our long-term vision of being a premier youth development organization in the region.
