EXECUTIVE SUMMARY

The quality of life in a community is driven by employment opportunities, good local schools, decent and safe housing and neighborhoods, effective services, natural beauty and aesthetics, and abundant cultural and recreational opportunities. Parks, trails, and open spaces are key contributors to the Village of Poynette's high quality of life. The Village's recreational system has been designed and managed to focus on the types of spaces and facilities desired by residents and to provide a fair geographic distribution.

This 2023-2027 Parks and Open Space Plan charts the future of the Village's park, trail, and open space system. It updates the 2018-2022 Parks and Open Space Plan, which has led to new and improved parks and trails, including a repurposed Jamieson Park and the "North-South" trail that was aided by a State grant.

As guided by the Village's Parks and Recreation Commission, the 2023-2027 Parks and Open Space Plan includes the following priorities:

- 1. Develop the Village's Trail Network. The Rowan Creek Trail is one of the most popular aspects of the Village's recreational system. The Village will work to extend the Rowan Creek Trail west to Jamieson Park as its highest priority, ideally through the Columbia County Sportsman League property which was actively being pursued for acquisition at time of writing. Extension of the trail east to the high/middle school campus and then north to the intersection of Seward Street and Highway 51 is also envisioned. There are environmental, property ownership, and cost challenges associated with this eastern extension. Some of these may be bypassed such as by following existing streets and sidewalks for parts of the route. Other trail projects are suggested to develop a true network within the Village and to key destinations like the Mackenzie Center.
- 2. Continue to Improve Existing Parks. The Commission envisions improvements to a number of Village parks. These include (but are not limited to) replacement playground equipment and other improvements in Pauquette Park, continued improvement to Jamieson Park guided by its 2019 park master plan, a natural playground and respite space in Colby Park, and improvements to Old Settlers' Park guided by a future park master plan. Old Settlers' Park improvements are worn, and despite containing approximately 700 residents, the part of the Village south of Rowan Creek does not have any public playgrounds.
- 3. **Modernize Park and Trail Signs.** With rare exception, the Village's existing park and trail signs are badly worn and out of date. Further, for residents and visitors alike, the bike trail network is not easy to follow and park locations are not always obvious. The Commission therefore envisions a fully updated and extended system of identification signs for all parks, plus new and extended trail signs, all under a unified, modern brand.

Chapter 1: INTRODUCTION

This *Plan* is a guide for improvement of parks, trails, open spaces, and outdoor recreation facilities in Poynette from 2023 through 2027. The Wisconsin Department of Natural Resources (WDNR) requires each community to prepare and adopt a five-year parks and open space plan—also known as a "comprehensive outdoor recreation plan"—to maintain eligibility for State and Federal recreational grants. Over the past five years, Poynette used its last plan as a springboard to two such grants. Like the prior versions, this updated *Plan* follows WDNR's "Guidelines for the Development of Local Governmental Comprehensive Recreation Plans."

The *Plan* is also a detailed element of the Village's comprehensive plan—its long-range community development guide. The *Village of Poynette Comprehensive Plan* is primarily articulated through an updated document adopted in January 2017 and last amended in 2021. This *2023-2027 Parks and Open Space Plan* controls to any extent that parks and recreation-related recommendations differ between the two documents. Any differences are minor. The 2017 *Village of Poynette Comprehensive Plan* includes only broad direction for the parks system.

Description of the Planning Process

This 2023-2027 Parks and Open Space Plan largely represents an incremental update to the five-year plan that preceded it. The Parks and Recreation Commission guided the Plan update through three workshop-type meetings and a parks system tour in April 2022. Community input was solicited through stakeholder interviews and a community survey, with results of both presented later in this Plan.

Ongoing Monitoring, Amendments, and Update

The Village—mainly through the Parks and Recreation Commission—will review this *Plan* and its capital improvement and maintenance program priorities as part of the annual budget process. Substantive changes to recommendations will be incorporated through *Plan* amendments as appropriate. The Village intends to complete a formal update of this *Parks and Open Space Plan* in 2027—both to maintain the Village's eligibility for grant programs and reflect evolving park and recreation needs.

Chapter 2: VISION, MISSION, GOALS, OBJECTIVES, AND POLICIES

The Village park system is managed by the Poynette Parks and Recreation Commission. The Commission has adopted the vision and mission statements and the goals, objectives, and policies in this chapter as the foundation for its activities and this *Plan*. A goal is a broad statement that reflects the vision and priorities. Objectives are tangible elements that, in aggregate, advance the goal to which they relate. Policies usually articulate measurable standards or targets, and include or advise particular actions that achieve objectives.

Vision Statement

The vision of the Poynette Parks and Recreation Commission is for the Village to have one of the best municipal parks and recreation programs in the Madison metropolitan region.

Mission Statement

To realize our vision, the mission of the Poynette Parks and Recreation Commission is to:

- raise public awareness of the Village's assets and opportunities,
- support recreation program leaders and volunteers,
- improve park and trail facilities,
- expand recreation program offerings,
- nurture partnerships throughout the Village, and
- achieve recognition for these efforts throughout the region.

Goal

Provide and maintain sufficient parks, trails natural areas, and recreational opportunities to support the health, safety, and quality of life of current and future Village residents and visitors.

Objective 1: Acquire and manage parklands and recreational facilities to meet the needs of Village residents.

- Policy 1. Maintain an inventory of improved parkland at an overall per capita
 ratio that exceeds the National Recreation and Park Association (NRPA_
 standard of at least 10.5 acres of improved public park land—exclusive of special
 parks and open space facilities—per 1,000 residents.
- Policy 2. Locate parks and provide safe and convenient pedestrian routes so that each home is within less than a 15 minute walk of a park or playground.

- Policy 3. Acquire and consolidate new park lands through land dedication requirements in the Village's land division regulations when residential subdivisions are proposed.
- Policy 4. Consider opportunities to acquire additional lands for parks and natural areas, especially for rail corridors, connection with or expansion to existing public lands, and/or preservation of unique or sensitive environmental areas.
- Policy 5. As part of each five-year update to this Parks and Open Space Plan, conduct a parks and recreation services opinion survey of residents and/or engage in other meaningful input efforts.
- Policy 6. Annually monitor participation in the various park and recreation land and programs to gauge demand and determine appropriate support for future facility and program improvements and changes.

Objective 2: Provide safe and accessible park and recreational facilities.

- Policy 1. Design and construct new and renovated park facilities to be compliant
 with the Americans with Disabilities Act (ADA) and the concept of "universal
 design" to the extent allowed by factors like terrain and cost.
- Policy 2. Ensure that every park has an identifiable entry point, legible sign(s), proper addressing, and a paved pedestrian and emergency vehicle access route to an improved public street.
- Policy 3. To the extent practical, install and/or reconstruct sidewalks and trails to provide safe and barrier free routes for pedestrian and bike travel between residential neighborhoods and park and recreation facilities, and between parks.
- Policy 4. Resolve remaining issues regarding ownership and access to existing Village parks to reflect commonly understood boundaries and access routes.

Objective 3: Provide a diversity of multi-seasonal and multi-use recreational opportunities.

- Policy 1. Formulate an investment and maintenance program for each park, including a replacement schedule for play structures based on manufacturer instructions where available.
- Policy 2. Support and manage special purpose parks and open spaces to provide outdoor gathering places, aesthetic enhancements, and/or enhanced opportunities to appreciate cultural resources and heritage.
- Policy 3. Use a capital improvements program to implement proposed major investments in the Village's park and trail system, as laid out in this *Plan* (see Table 2 near the end of this *Plan* in particular).

• Policy 4. Support winter use and programming of Village parks through both time-tested and creative programming. See <u>Active Living: a Winter Playbook for</u> Wisconsin for ideas and inspiration.

Objective 4: Preserve, manage, and promote appropriate use of parklands, the Rowan Creek corridor, and other environmental resources in and near the Village.

- Policy 1. Through the Village's land development ordinances and processes, require the demarcation of sensitive environmental areas such as wetlands, natural drainageways, floodplains, slopes steeper than 20%, unique geologic or topographic features, and special and unique habitats. Work to protect conservancy areas with limitations on uses and activities to mitigate adverse impacts, such as through the Village's Conservation Overlay zoning district.
- Policy 2. Implement appropriate land management practices on Village owned properties, and encourage management of private property, to minimize invasive plant and animal species and maximize the use and propagation of native plant communities.
- Policy 3. Formulate and implement appropriate park use guidelines to accommodate recreational uses and mitigate adverse ecological impacts on environmentally sensitive lands.
- Policy 4. Emphasize the protection and enhancement of the Rowan Creek corridor as the community's premier natural resource, gathering place, and attraction.

Objective 5: Improve the inter-connectivity of Village parks and open spaces.

- Policy 1. Provide safe, convenient, and identifiable pedestrian and bicycle connections among parks, the downtown area, residential neighborhoods, and Poynette schools.
- Policy 2. Extend trails in and around Poynette to form an interconnected network including loops where possible.
- Policy 3. Encourage, as appropriate, the use of environmental corridors and utility corridors for walking, bicycling, cross-country skiing, and other quiet uses.

Objective 6: Coordinate the development and management of parks and recreational facilities with other governmental agencies.

• Policy 1. Continue and expand the Village's relationship with the Poynette School District for the joint development and maintenance of neighborhood playground facilities and other recreation opportunities.

- Policy 2. Cooperate with Columbia County and the State of Wisconsin in interconnecting parks and trails and in accommodating regional recreational activities and facilities.
- Policy 3. Incorporate and advocate for pedestrian and bicycle facilities in Village,
 County, and State street and highway improvement projects.

Objective 7: Broaden the social and economic role that parks and open spaces perform for the community.

- Policy 1. Encourage park stewardship by supporting community groups and businesses to assist with maintaining and developing the Village's Park System.
- Policy 2. To the extent practical and appropriate, support regional events that utilize the Village's park system.
- Policy 3. Incorporate Village recreational and natural area opportunities into community marketing and promotional efforts.
- Policy 4. Assure that all Village residents have ready access to Village parks and trails—regardless of place of residence, income, age, mobility, and autoownership.

Chapter 3: COMMUNITY CONTEXT & PLANNING CONSIDERATIONS

Demographic Characteristics

The Village experienced a period of significant population growth (+36%) and housing unit construction (+43%) during the 1990s. The Village's year 2000 population was 2,260 people. Significant population growth continued through the mid-2000s, and by 2010 the Village population was 2,528.

The Great Recession of the late 2000s had a significant negative impact on the growth of Poynette and other communities like it. While suburban areas closer to Madison emerged from the recession with significant housing and population growth by the mid-2010s, places like Poynette typically have not due to rising development costs, lower birth rates, and other factors. Poynette has not had any new residential subdivisions developed since Woodland Ridge on its south side in 2007.

As a result, the Census Bureau reported Poynette's year 2020 population at 2,590—an increase of 62 people since 2010. The Census Bureau also reported 1,143 housing units in Poynette in 2020—a reported increase of only 21 units during the 2010s (local building permit records are a little different).

Population characteristics in Poynette have also changed over the past decade, as follows:

- Average household size was 2.4 persons in 2010 and 2.3 persons in 2020 (1,075 households).
- In 2010, 13% of residents lived alone, 52% in households with children, and 35% in households without children. By 2020, 34% of residents lived alone, 33% in households with children, and 34% in households without children.
- In 2010, 30% of residents were children, 60% were adults between 18 and 65, and 10% were older than 65. By 2020, 26% of residents were children, 61% were adults between 18 and 65, and 13% were older than 65.

Together, these statistics suggest an aging population, likely affected by a large number of older students in 2010, a general lack of new housing options in the community over the past decade, and a declining birth rate that is common among smaller communities.

Population Projections

In the 2017 *Village of Poynette Comprehensive Plan*, the Village's planning consultant forecasted Village population growth over the next 20 years at a rate of 1% to 2% per year. This rate is likely dependent on the construction of new housing at a greater rate than has occurred over the past decade, which the Village is working to achieve.

This park planning effort presumes a 1% annual growth rate for the 2023 to 2027 planning period, which would result in about 2,777 residents by January 1, 2027.

Village Recreation Program Participation

Residents of the Village and surrounding areas have access to a variety of recreation programs and organizations that utilize the Village park facilities, including:

- Youth Baseball/Softball
- Adult Baseball
- Youth Football (flag and tackle)
- Youth Soccer
- Poynette Area Gardening Association
- Poynette Historic Society
- Boy Scouts
- Girl Scouts
- 4H



Reflecting the modest projected population increase, demand for most adult and youth recreation facilities and programs will likely be stable through 2027. Interest in specific types of facilities and programs will continue to shift.

As part of this *Plan* update process, the Village's planning consultant in 2022 obtained information on current and projected needs from the following user groups:

- Friends of Rowan Creek Water quality awareness is important, including
 maintaining sewage plant performance, managing stormwater, and limiting winter
 saltwater use and runoff. Extending trails would be favorable including
 accommodations for people with disabilities. Further using Rowan Creek for
 educational outreach opportunities with the nearby schools is also desirable.
- Youth Softball The community would benefit from one additional softball field and new overhead lights at the baseball field in Pauquette Park. A bike rental post would be desirable once the trails have been more fully developed.
- Youth Soccer The youth soccer program is seeking participation growth but could use community member and enhanced Village support and coordination to do so. Use and maintenance of fields at Valley View Park is acceptable.
- **Adult Baseball** Continued commitment from the Village to maintain Pauquette Park for baseball is desired.

- Poynette Area Gardening Association (PAGA) The community garden has
 progressed and expanded in the last 22 years but could use greater financial
 support from the community or Village government. Maintenance equipment
 needs replacement. The addition of a new greenhouse will add to year-round
 maintenance and utility costs, therefore PAGA is seeking the help of businesses
 and residents to for a new adopt-a-planter program.
- Wisconsin Department of Natural Resources (WDNR) Continued communication between the Village and the WDNR property manager for the Rowan Creek State Fishery Area is desired, such as for trail interconnections. The WDNR has an ongoing timber management project in the Fisheries Area that will result in temporary closing of trails for timber cutting and removal, invasives species control, and tree planting. The WDNR has no major improvements planned for the Rowan Creek Fishery Area.
- Former Plan Commissioner, Local Historian, and Naturalist Lynn Hanson –
 More adult recreational areas and activities would be desirable, as would a
 community center and programming for young people. The trail system should
 be expanded Village wide and the County bike route through the Village should
 be better marked. Rowan Creek should be sustained as a natural and
 community asset. Old Settlers' Park is a historical and archeological landmark,
 which should be factored into any plans for changes in that park.
- Poynette School District Future or desired recreational improvements include a replacement scoreboard for youth softball, skinning of the North Street field infield, recrowning of the football field, and field light replacement. Youth football remains in need of additional space for practices and games. Expansion of trails and associated signage for students and their families would be desirable.

In sum, continuing to be responsive to stakeholder expectations (and changes in demand) and maintaining a high level of participation and excitement for parks will be critical to the Village's ability to foster and maintain community support for facilities and programs.

Community Development Patterns

Increasing opportunities for physical activity is key to mental and physical health, including addressing the rising trend of obesity. The physical layout of a community can promote or limit opportunities for physical activity. Walkable communities with plentiful and accessible parks and trails are healthier communities. In such communities, more people are willing to walk or bike to school, shopping, and jobs, and to use parks for physical activities. The COVID-19 pandemic only increased the importance of walkable communities with ample outdoor recreational spaces.

In general, though bisected by Rowan Creek and US Highway 51, the Village has developed in a relatively compact urban form surrounding the historic downtown area. Nearly all parts of the community are within a 15 to 20 minute walk from Village Hall and adjacent Pauquette Park. Recent sidewalks, crossing improvements, and trails have aided with walkability, but there remain gaps in this system.

The Village's current residential character is predominantly single family detached homes with some duplexes, mobile homes, multiple family units in limited spots. Density of the existing neighborhoods is approximately 2.2 dwelling units per net residential acre.


Through its adopted *Comprehensive Plan*, the Village anticipates compatible changes to the existing land use pattern, largely within the current boundaries of the Village.

The most significant and immediate area planned for neighborhood development is near the northwest corner of the Village. This northwest corner includes the platted but undeveloped West Ridge subdivision. At time of writing, the Village was working with a developer on a plan to replat West Ridge to ultimately accommodate more than 300 single family homes and up to 150 multiple family housing units, and proposed to include replacement of two previously-platted pocket parks with about 9.5 acres of centralized public park. Plans may change before final approval. Development would be phased over a number of years, and would likely absorb the vast majority of residential demand in Poynette over that time.



This conceptual neighborhood development plan for the replatting of West Bridge, submitted in May 2022, would result in substantial park expansion. Suggested park areas are in green; subject to change.

Three other areas of future neighborhood expansion are anticipated, as depicted in cross-hatched areas with the pie shapes on the Village's future land use map to the right. One is at the northeastern edge of the Village (generally north of Pauquette Pines Lane), one is at the eastern edge (east of the cemetery and mobile home park), and one is at the southern edge (south of County Highway Q). Residential densities are projected to be around 4 dwelling units per acre on average – predominantly single family homes but also including duplex and multiple family units. At time of writing, there were no short-term development prospects at any of these locations.



This future land use map from the Village's Comprehensive Plan shows other areas for future neighborhood development (cross hatched with "pies"), which suggests potential longerterm park locations.

Areas planned for higher-density residential use (e.g., apartments) are mainly near the Highway 51 corridor. In 2020, there was a conceptual development proposal for new apartments east of Family Dollar, but that proposal has yet to advance.

Community History

Awareness of and sensitivity to historic and cultural resources fosters a sense of pride and provides and important feeling of social and cultural continuity between the past, present, and future. Historic and cultural preservation and interpretation can also provide economic benefits to property owners and the community. They also expand the variety of recreational opportunities (such as history walks and founder's day events) that contribute to the fabric of a community's character and desirability as a place to live.

The first non-indigenous settlers arrived in the Poynette area in the 1830s and established a trading outpost with the native American peoples living in the area. Wallace Rowan, who is thought to be the first settler in Columbia County, is the namesake of Rowan Creek. The former location of the Rowan cabin is within Old

Settlers' Park. On February 8, 1837, 120 acres of land was laid out for the village of Pauquette, named for Pierre Pauquette, the son of a Frenchman and a Winnebago Indian woman, an agent and interpreter employed by the American Fur Company at Portage who spent much of his time in the Rowan Creek area. It was not until 1850, when the village of Pauquette made application for a post office, that it was discovered that the name had been recorded as Poynette due to poor penmanship. By 1883, the Village had already been a railroad stop for 13 years, and had grown to a thriving community supporting the surrounding agricultural economy with two grist mills and 55 business establishments (including a roller-skating rink).

The Wisconsin State Historical Society's Architecture and History Inventory (AHI) includes 19 documented properties within the Village of Poynette, including homes, institutional and commercial buildings. Historic properties found in this list may also have been certified for the tax credit programs for the rehabilitation of certified historic properties. Currently, there are no properties in Poynette listed in the State or National Registers, or determined to be eligible for the Register. However, properties may be named to the Register in the future.

Historic and archeological resources within Poynette's parks are described in the next section of this *Plan*.

Landforms and Natural Resources

The extensive natural resources in the vicinity, and especially Rowan Creek, have contributed greatly to the character of the community and are highly valued by residents and businesses ("Poynette – Naturally"). Protecting these resources and enhancing accessibility for community and area residents will be extremely important to maintaining the desired quality of life.

In the immediate vicinity of the Village, landforms range from lowlands and wetlands along Rowan and Hinkson Creeks to rolling fertile farmland, to steep wooded hillsides and ridges. This variety of natural features contributes to the attractive vistas and diverse habitats that characterize and define the Village's identity.

The Village is located in the center of the 56 square mile Rowan Creek Watershed – a picturesque natural setting. Based on a 1998 WDNR data base, land cover in the watershed was 70% agricultural, 29% woodlands and wetlands, and 1% developed. This watershed drains to Rowan Creek and its tributary, Hinkson Creek. Rowan Creek

meets the Wisconsin River approximately 3.5 miles west of the Village. Rowan Creek, which passes through the southern portion of the Village, is designated as an Exceptional Water Resource by the WDNR, and the reaches of the stream located within the Village limits are considered to be Class I trout water. Hinkson Creek, which meanders less than one-half mile north of the present Village limits, is a lower grade, Class II trout stream. Within the watershed, WDNR has acquired and protected over 650 acres of land adjoining these streams as a Public Fishery Area. Roughly 200 acres of this Public Fishery Area is within the current Village limits.

The diversity of the ecological communities in and near the Village support a wide variety of native plants, mammals, birds, fish, reptiles, and



insects. The WDNR's Natural Heritage Inventory data base has identified at least 26 rare, threatened, or endangered plant and animal species in the area.

Regional Outdoor Recreation Features and Attractions

The surrounding area has many recreational opportunities which relate to, and in turn, can be complimented by the Village of Poynette park and trail system.

Noteworthy among the many regional recreation attractions is the Mackenzie Environmental Education Center, located less than one mile east of the Village. Established in 1934, the Mackenzie Center is one of the largest environmental education centers in the state. With over 250 acres of diverse habitats the center offers a variety of opportunities for outdoor experiences including: hiking, picnicking, snowshoeing, and conservation education. WDNR assumed full operation of the Mackenzie Center in 2014. It continues to offer environmental education programs in partnership with Friends of Mackenzie.

In addition to the resources found in and near the Village, many other recreational features and attractions are within a short car or bike trip from the Village, including:

The Wisconsin River
Gibraltor Bluff
Parfrey's Glen Natural Area
City of Portage historic sites

The Merrimac Ferry Devils Lake State Park Goose Pond Wisconsin Dells Since 1965, the State of Wisconsin has developed and maintained its Statewide Comprehensive Outdoor Recreation Plan (SCORP) to classify, measure, and ultimately provide for the preferences and needs of a statewide recreating public. The SCORP is updated every five years. In addition to providing a blueprint for policy and an overview of recreation trends, the document is used as a way to help allocate federal funds equitably among local communities.

The 2019-2023 SCORP has a particular focus on promoting the relationship between outdoor recreation and public health, providing opportunities for outdoor recreation in urban Wisconsin, and exploring public/private partnerships as a way to maintain open space for public use. In addition, the SCORP provides goals and actions aimed to expand outdoor recreation. These goals are intentionally broad and are meant to help local policymakers align their recreational needs with those of the State.

The following are the goals for outdoor recreation outlined in the 2019-2023 SCORP:

- 1. Boost participation in outdoor recreation
- 2. Grow partnerships
- 3. Provide high-quality experiences
- 4. Improve data to enhance visitor experiences and benefits
- 5. Enhance funding and financial stability

The objectives identified in this Village *Parks and Open Space Plan* fit well with the goals in the 2019-2023 SCORP. The following list assesses each Village objective with the State goal (or goals) that best align with it:

- Acquire and manage parklands and recreational facilities to meet the needs of Village residents. (Supporting 2019-2023 SCORP Goals 1, 2, and 3)
- Provie safe and accessible park and recreational facilitates. (Supporting SCORP Goals 1 and 3)
- Provide a diversity of multi-seasonal and multi-use recreational opportunities.
 (Supporting SCORP Goals 1 and 3)
- Preserve, manage, and promote appropriate use of parklands, the Rowan Creek corridor, and other environmental resources in and near the Village. (Supporting SCORP Goals 1, 2, 3 and 5)
- Improve the inter-connectivity of Village parks and open spaces. (Supporting SCORP Goals 1, 2, and 3)
- Coordinate the development and management of parks and recreational facilities with other governmental agencies. (Supporting SCORP Goals 2, 3, 4 and 5)

• Broaden the social and economic role that parks, and open spaces perform for the community. (Supporting SCORP Goals 1, 2, 4 and 5)

Relevant Village Comprehensive Plan Components

Beyond the future land use map presented earlier in this chapter, the 2017 *Village of Poynette Comprehensive Plan*, last amended in 2020, articulates several recommendations that have bearing on outdoor recreation in the Village. The community vision from the Comprehensive Plan is re-stated below.

Village of Poynette Vision

The future economic and community health of Poynette is directly linked to the preservation of natural resources and small-town and rural character. Preservation and enhancement of these assets through comprehensive, coordinated planning – along with the cooperative implementation of economic development initiative – will ensure a continued high quality of life.

In addition, the *Comprehensive Plan* has the following applicable goals:

- Natural Resources Protect the Village's natural resources and engage in environmental sustainability.
- Cultural Resources Preserve and build on Poynette's historic and cultural character.
- Land Use Promote a future land use pattern containing a sustainable mix of uses and buildings.
- Transportation Provide a safe, integrated, and efficient transportation system.
- **Utilities and Community Facilities** Provide safe and sustainable public utilities, facilities, services, and parks.
- Housing and Neighborhood Development Encourage a variety of housing types and neighborhood environments.
- **Economic Development** Strengthen, support, and promote growth of businesses and economic development districts, consistent with community resources and identity.
- **Intergovernmental Cooperation** Promote cooperation with the communities in the Poynette area.

Chapter 4: POYNETTE'S EXISTING PARK SYSYTEM

For park planning purposes, each of the Village's parks is categorized as either a:

- Neighborhood Playground,
- Neighborhood Park,
- Community Park, or
- Special Park and Open Space.


These categories are defined below and are based on the standards that appear in "Recreation, Park and Open Space Standards and Guidelines" (4th Edition) published by the National Recreation and Park Association (NRPA).

The Poynette park system currently includes 10 parks – two of which are future sites within an approved but as yet undeveloped subdivision in the northwest corner of the Village (West Ridge). These two parks may be consolidated into one larger park with the prospective replatting of West Ridge. The eight other parks encompass 76 acres, of which approximately 43 acres have been improved for active recreational use.

Information about existing Village parks and trail facilities is presented in Table 1: Existing Public Park Facilities, April 2022, Map 1: Existing Parks and Trail Resources, and the below narrative.





Neighborhood Playgrounds are Village-owned and typically serve a residential neighborhood within a $\frac{1}{4}$ -mile to $\frac{1}{2}$ -mile radius from the park. They are generally small—between one-half and 2 $\frac{1}{2}$ acres in size—and primarily include playground equipment, benches and picnic tables, and small informal play areas serving the immediate neighborhood.

The Village currently has four (or five) neighborhood playground locations, but only one that is improved, as follows:

- Columbia Park This park is about ¾ acre and is located on a neighborhood walkway between Columbia Drive and Eagle Lane, near the northeast corner of the Village. It has playground equipment and a small shelter with picnic tables.
- Colby Park Located in the northern part of the Village, this unimproved parcel (except for a sign) encompasses approximately 0.8 acre and adjoins a segment of the Village's stormwater drainage swale network.
- South Park Located in the far south part of the Village, this site is an unimproved ½ acre triangular parcel with a narrow access easement across
 - an adjoining residential lot north to County Highway CS.
- Two un-named park sites in the northwest neighborhood Two sites have been dedicated in the approved but as yet undeveloped West Ridge subdivision, but these may be consolidated and expanded to a larger neighborhood park via a proposed replatting.







Neighborhood Parks provide space for informal recreation opportunities for residents in the surrounding neighborhood and to a degree, also provide facilities for the entire community. These parks are typically 3 to 9 acres in order to accommodate space for play areas and are often improved with facilities for organized sports such as a ball

diamond, small soccer fields, and a basketball courts, offstreet parking, and playground equipment.

The Village currently has one neighborhood park:

Old Settlers' Park – This wooded 2.6 acre park is located at 100 Old Settlers' Trail, on the Village's south side. Its adjacency to the Village's wastewater treatment plant site including a wooded area on its south end, provides a perception of a larger park. It has a small playground and a hard surface play area for half-court basketball—both of which were old and in marginal repair at time of writing. Wallis (or Wallace) Rowan established a cabin in what is now Old Settlers' Park that was used as a home, trading post, and inn for travelers along the Old Military Road. This is recognized as an archeological site (CO-0246) by Wisconsin Historical Society, and a Wisconsin Historical Marker was dedicated in the park in September 2012 as a joint project of the Wisconsin Historical Society and the Poynette Area Historical Society.





Community Parks

Community Parks are larger recreation facilities that serve the Village-wide population as well as functioning as a neighborhood park/playground for the immediate neighborhood. Community Parks are generally larger than 9 acres to provide adequate area for specialized and unique facilities such as ball diamonds or play fields designed for organized competitive sports, off-street parking, and shelter and restroom facilities. Community Parks may have lighted playfields, spectator areas, concession areas and special facilities such as a swimming pool, ice arena, boat launch, and camping sites.

There are three developed Community Park sites in the Village: the centrally located Pauquette Park/Veterans' Memorial Park complex, Valley View Park on the near west side of the Village, and Jamieson Park, described as follows:

Pauquette Park – Located in the heart of the Village immediately south of the downtown business district, this 13.3 acre park encompasses heavily used baseball and softball diamonds, a large picnic pavilion, smaller picnic shelters, playground equipment, and a paved perimeter walking path.



Pauquette Park is also the primary trailhead for the Rowan Creek Trail. It includes a parking lot along Main Street, which in winter months has provided space for an outdoor ice rink.

- Veterans' Memorial Park This
 3.7 acre park is across the street
 from Pauquette Park, with which it
 shares a parking lot. It currently
 provides open play area, picnic
 shelters, and community gardens.
 It is also the location of the
 Poynette Veterans' Memorial.
- Valley View Park This 9.2 acre park is located on the near west side of the community. Valley View Park currently encompasses 5.3 acres of Village owned property and approximately 4 acres of land leased from Columbia County. The Village has an agreement that will enable acquisition of additional lands from the County for future park expansion. In 2011, the Village made substantial improvements to





Valley View Park. These included soccer field upgrades, a new picnic and

concession pavilion, upgraded playground facilities, a 1/3 mile perimeter walking path, and a 2,500 square foot "Spray Pad" water playground.

 Jamieson Park – Located on the County Highway CS approximately one mile west of downtown, this 45 acre park has a picnic shelter, dog park, 9-hole disc golf course, and trail access to Rowan Creek. The disc golf course and dog park were added following a park master planning process in 2019—the park master plan is reproduced/updated later in this Plan document as Map 3. The park



formerly had 10 camper/tent sites that were closed at the end of 2016, mainly based on cost associated with State rule compliance. Approximately 32 acres of the site is native wooded and marshy habitat.

In Spring 2022, the State Archaeologist toured the wooded area of Jamieson Park and found no evidence of Native American burial sites, based on the lack of surface features. Jamieson Park was originally named Muir Park. The original intent of the park was to be a natural park where people could appreciate nature and connect with the life of John Muir—a naturalist, author, environmental philosopher, glaciologist, and early advocate for wilderness preservation with a strong local connection.

Special Purpose Parks and Open Spaces

Special Purpose Parks and Open Spaces are recreational and open space facilities designed to serve a specific purpose, such as a stand-alone event facility or trailhead locations for walking, bicycling, and ski trails. At present, the following is considered the only Special Purpose Open Space in Poynette:

 Northwest Trail Corridor – Located on the Village's northwest side, at present this corridor serves only drainage purposes, except that a small segment near Washington Street also has a trail.

Rowan Creek and Village Trail Network

There are 3.9 miles of paved and un-paved walking paths and trails in the Village, not including sidewalks. These are represented on Map 1. Trails in the Village feature nearly 1 mile of paved trail in Pauquette Park, 1.8 miles of paved and limestone trail along Rowan Creek outside of Pauquette Park and generally managed by the WDNR,

over 1/3 mile of paved trail in Valley View Park, and new trails along North and South Streets.

Non-Village Owned Recreational Facilities

Non-Village park and recreation opportunities are available in and near Poynette.

WDNR manages two recreational spaces of regional significance. Nearly 200 acres of the State's Rowan Creek State Fishery Area are located within the Village limits. The 250-acre Mackenzie Environmental Education Center is located just east of the Village and provides a wide variety of outdoor settings for hiking, cross country skiing, and family outings.

The Poynette School District provides a variety of recreational opportunities to the community from its 28-acre high-middle school campus along Highway 51 and its new 33-acre elementary school site along North Street. These offerings include the following:

- **Indoor Swimming Pool** The pool provides open swim, lap swim, water aerobics, swim lessons, and special events.
- **Gymnasiums** The high school has two gymnasiums and the elementary school has another. These are used for open recreation and organized sports.
- Outdoor Sports The high school/middle school campus provides space for youth softball and youth football. The District has identified a space need for youth football, particularly for practices, as the high school football field use is restricted. The new elementary school site includes a ballfield and parking lot along North Street, with the District intending to skin the infield.
- Outdoor Playgrounds The District upgraded the elementary school playground in 2014, which now serves as the middle school playground. The playground, plus a paved play area, is located near Seward Street. The new elementary school on North Street has its own playground.

Shepherds Meadow Golf Course is a 9-hole golf course, with clubhouse and restaurant, located on Links Drive on the northeast side of the Village. It is a privately-owned course open for public play.

Finally, Columbia County owns 32 acres of generally open land just south of Valley View Park, including the nearly 4 acres adjacent to the park it leases to the Village for soccer fields. The County is currently undergoing a remediation process for its 32 acres, expected to be concluded within the next five years.

Chapter 5: PARK SYSTEM NEEDS

In small communities, it is often difficult to compare a local park system to the standards recommended by the National Recreation and Parks Association (NRPA). Nevertheless, understanding the amount of parkland that is conveniently and safely accessible to community residents is an effective way to articulate the character of a community, to describe its valued quality of life, and to assess parkland needs.

Two basic criteria provide the framework for the NRPA recommendations for adequate park facilities, described in the following sections.

Acres of Parkland per Capita

The NRPA recommends at least 10.5 acres per 1,000 population. This total recommended park area is generally allocated as 1.25 to 2.5 acres of neighborhood parks per 1,000 people, and 5 to 8 acres of community parks per 1,000 people.

The Poynette park system currently provides improved parkland within neighborhood playgrounds, neighborhood parks, and community parks totaling 42.7 acres. When allocated to the 2020 Village population of 2,590, this equates to 16.5 acres per 1,000 population overall.

Therefore, based on the NRPA's parkland area per population standard, overall, the Village of Poynette currently has an adequate amount of land improved for recreational uses. The current parkland inventory also meets the NRPA recommendations for the 2027 projected population of 2,777 people.

To maintain the current ratio of parkland per 1,000 population, the Village would need to acquire new parkland at a rate of 1,307 square feet per new dwelling unit (based on recent demographic characteristics of 2.4 people per dwelling unit). Accordingly, in 2014, the Village amended its land division ordinance to require 1,307 square feet of parkland dedication per new residential lot.

Effective Park Service Areas

NRPA recommends that parks should be safely and conveniently accessible within a 10 to 15 minute walk from every residence (typically measured as a ¼-mile to ½-mile radius from the park). Evaluating park service areas also must consider the fact that major highways, railroads, and other barriers effectively reduce convenient access.

In a small community such as Poynette, evaluating $\frac{1}{4}$ - and $\frac{1}{2}$ -mile service areas provides minimal value for assessing the adequacy and distribution of park facilities since essentially the entire community is within a 15 to 20 minute walk from the downtown.

A more useful review threshold is to evaluate park distribution in terms of the safety and convenience of the walking and bicycling routes that can be used to get to any given park. In other words, all parks should be reasonably accessible to residents within a ¼-mile walk via a convenient, barrier free, and safe route.

Within the Village, there are four major "barriers" that limit the walk-ability and bikeability to access the Village Park System:

- US Highway 51, due to high traffic volumes and speed
- County Highway CS, due to high traffic volumes and speed
- Railroad, due to the hazardous nature of rail traffic (though infrequent), and
- Rowan Creek, a natural feature currently with only two improved pedestrian crossings (the Main Street and Pauquette Path bridges).

A related consideration to safe pedestrian travel is limited amount and poor surface condition of sidewalks in some areas of the Village—particularly the south side. Most existing residential areas in the Village are accessible to a public park or playground with the exceptions of:

- the neighborhood between the railroad and US Highway 51 (though this area does have limited access to the middle school playground),
- the residential neighborhood east of US Highway 51 between the Cemetery and County Highway Q, and
- south side neighborhoods along and near County Highway CS.

As the Village grows, additional Neighborhood Parks and Neighborhood Playgrounds should be located within a ¼-mile radius of future residential neighborhoods. Refer to Map 2 for the Village's plan, later in this document, for future parks advised in conjunction with residential expansion indicated in the *Village of Poynette Comprehensive Plan*. This includes the likely consolidation and expansion of park space in what was formerly known as the West Ridge subdivision near the Village's northwest corner.

Additionally, better sidewalk and path access should be provided to existing improved parks. Improved walkable linkages between existing neighborhoods and parks will address park facility access limitations, significantly improve pedestrian safety, expand the overall trail network in the Village, and reduce the need to significantly improve all existing parks. Refer also to Map 2 for the Village's general plan for future off-street

trails, and descriptions in Table 2 and elsewhere in this document for priority trail recommendations.

Handicapped Accessibility/Universal Design

The Americans with Disabilities Act (ADA), enacted in 1990, states the right of equal access for persons to local government services such as parks. New facilities must comply with the ADA and provide accessibility. There are fundamental differences in how accessibility in the outdoors is accommodated compared to indoor or the built environments, however. While restrooms, shelters, interpretive centers, playgrounds, and parking lots, for example, need to follow detailed ADA guidelines, other improvements such as trails, boat landings, and swimming beach areas do not necessarily need to follow standards for indoor or built environment ramp gradients or surfacing requirements. Nonetheless, it is good policy to make park and recreation facilities as accessible as possible to as many people as possible, including the use of motorized personal mobility devices (motorized chairs and scooters).

Outside of the legal framework, the words "universal design" have generally replaced "handicapped accessibility." Universal design is design that's usable by all people, to the greatest extent possible, without the need for adaptation or specialized design.

Recommended Size and Location of Neighborhood Playgrounds

While the Village's historical practice of obtaining and developing relatively small Neighborhood Playground facilities has provided some form of public recreational opportunity for children, the small size of these parks greatly restricts the type of play equipment that can be offered to Village residents. For example, in the Columbia Park neighborhood, a significant number of the residences near the park have larger and more elaborate playgrounds than are found in the park itself. The cost efficiencies of park maintenance efforts (expenditures) is also a consideration for the Village as it is likely more efficient to maintain a single 1.5 acre Neighborhood Playground than three one-half acre playgrounds serving the same neighborhood.

Future Neighborhood Playgrounds should be a minimum of 1 acre in size, and may be located generally where indicated on Map 2.

Recommended Size and Location of Neighborhood Parks

Neighborhood parks provide open space and recreational amenities to the surrounding neighborhood. There is increasing interest (demand) for more open play areas to accommodate informal play and field sports facilities (soccer, football, Ultimate Frisbee, softball, and lacrosse) in the community.

Future Neighborhood Parks should be a minimum of 3 acres in size, and should generally be located where indicated on Map 2.

Park Needs Articulated through the Community Survey

As part of this *Plan* update, the Village conducted a community survey of Village residents related to park and trail system interests. The complete survey results are included in the appendix.

There were 246 survey responses, which represents about 22% of Poynette households. A majority of respondents were between the ages of 30 and 49. About 75% of the respondents have lived in the Village for more than five years. More than half have one or more children under 13 years old, while about 1/3 have no children at home.

Nearly 40% of respondents reported visiting Village parks "once or twice a week," with "once or twice a month" the second most common response. Respondents' most-used facilities were recreational paths and trails (80%), followed by restrooms (66%), playground equipment (58%), water spray pad at Valley View Park (55%), and picnic shelters/pavilion (52%). Open play areas, Movies in the Park, and drinking fountains were also frequently mentioned. A similar survey in 2017 yielded similar results to these questions.

Of 20 potential park and recreational improvements listed, those with the greatest levels of support were more walking paths and trails (82%), a food truck pavilion with a central picnic area (72%), more or better playgrounds for school-aged children (72%), more bicycling/skating paths and trails (68%), and restroom facilities in more parks (68%). A fitness exercise course, music/performance amphitheater, basketball courts, pre-school playgrounds, more picnic shelters, and accessible fishing pier also received majority support. The 2017 survey showed similar support for more paths and trails, but greater support for more restrooms in more parks.

Of four listed "larger park and recreation projects the Village could potentially undertake in the next five or so years," "extending the Rowan Creek trail network to the west (e.g., to Jamieson Park) and/or east (e.g., to school campus)" received the greatest support. Nearly ½ even indicated that they would be willing to pay more taxes to see such a project happen. This and the "north-south" trail project also received the greatest level of support in the 2017 survey, among a somewhat different list of candidates. Continued revitalization of Jamieson Park and a new revitalization effort for Old Settlers" Park also received considerable support in the new 2022 survey—clearly more so than building a permanent ice skating facility.

Participants were then asked open-ended questions to provide further thoughts, comments, or questions on each of these same four potential projects, including desired locations. These responses confirmed the strong support for Rowan Creek trail expansion. Diverse opinions about further improvements to Jamieson Park were

shared, but considerable support was voiced for a trail connection to the rest of the Village. For Old Settlers' Park, most commonly mentioned wants were upgrading/ replacing the playground equipment and basketball court and establishing a sledding hill. There was mixed support for (and some confusion about) the potential for a zip line and gaga pit at Old Settlers' Park. Concerns that appear to have led to lower levels of support for a permanent ice skating facility included perceived or expected low usage, increasingly unpredictable winter temperatures limiting days available, and the Pauquette Park parking lot location being viewed as acceptable or preferred. Still, Veterans' Memorial or Valley View Parks were the most commonly identified locations for participates who advised a different, permanent site.

Participants were also asked to identify what types of recreational programming they would most like to have in Poynette, in addition to what is offered to students in the schools. The most common responses were Movies in the Park (53%), winter outdoor activities (49%), nature walks and interpretation (46%), and a community fun-run or walk (45%). Organized sports were generally among the least identified.

Finally, participants were asked an open-ended question about other potential improvements to Poynette's parks and trails participants would support the Village making over the next five years. The most common responses were new or refurbished basketball courts, more trails outside of the Rowan Creek area, and new or refurbished play equipment. A number of respondents took this question as an opportunity to encourage the Village to (better) maintain recreational lands and facilities it has now.

Chapter 6: GENERAL PARK SYSTEM RECOMMENDATIONS

In order to attract and keep new residents, the Village endeavors to both support a sustainable, vibrant economy and a sense of place and community for its residents. The Village recognizes that parks and trails are a major contributor to establishing and maintaining a high quality of life and for growing the local economy.

The following recommendations for park and trail operations, maintenance, acquisition, and capital improvements are advanced. It is expected that these recommendations will be reviewed and modified on a regular basis in order to:

- reflect community input on park, trail, and other recreational facility needs,
- be responsive to opportunities for acquisitions,
- be responsive to emergency situations to remove hazardous conditions, and
- reflect fiscal priorities and constraints established by the Village Board.

Operations and Maintenance

The Village's primary objective for operations is to be as cost effective as possible in maintaining the park and trail system to provide a variety of recreation opportunities that are safe, clean, and attractive to park users. Anticipated regular operation and maintenance activities include:

- Installing mulch rings or substitute around trees to simplify park mowing operations (generally 6 foot diameter).
- Pruning, removing, and replacing trees as noted in the Village's Urban Forestry Plan and Tree Inventory Summary.
- Reconstructing park sidewalks and paved pathways to be as wide as snow plowing equipment.
- Restoring expansive under-utilized playfield space and stormwater management swales with native grasses with minimal required mowing.
- Standardizing maintained facilities, furniture, and equipment for cost efficient maintenance.

The Parks and Recreation Commission will periodically review the scope of facilities and amenities that would typically be provided in each park in order to assure that the park system is meeting the needs of the community and that improvements are equitably distributed.

Parkland Acquisition

The Village population is projected to increase by around 200 people by 2027. Since the Village currently exceeds the National Park Standards of 10.5 acres per 1,000 residents, it *may* not be necessary to seek land acquisitions for new active park facilities, except:

- where new residential development is proposed, particularly associated with the proposed West Ridge replatting (Map 2 illustrates the general plan for future park sites in the Village),
- if opportunity presents itself to expand Jamieson Park to the east into property formerly used as a shooting range (at time of writing, the Village was negotiating its acquisition with assistance from a grant obtained through the WDNR),
- if opportunity presents itself to acquire County land southeast of Valley View Park,
- if opportunity presents itself for natural/wooded site acquisition between Old Settlers' Trail and Bluebird Circle, north of Highway CS, and/or
- as necessary to complete trail recommendations in this *Plan* or respond to other unique opportunities.

Since the natural landscape of the Village and its surrounding areas are a major component of the Village's image and character, the Village should be responsive to opportunities to protect and/or acquire and preserve native landscapes whenever possible. Strong consideration should be given to supporting opportunities to expand existing Village conservancy lands along Rowan Creek.

Parkland Dedication and Impact Fees

The Village's parkland dedication requirements are included as Section 1.07 of the Village's Land Division and Subdivision Ordinance. To help implement an earlier *Parks and Open Space Plan*, the Village updated its parkland dedication requirement (to 1,307 square feet per housing unit) and fees in-lieu-of parkland dedication (to \$450 per housing unit). No further changes are advised.

The Village also has an impact fee for park improvements, also included in Section 1.07 of the Land Division and Subdivision Ordinance. That impact fee, based on a study in the 2000s, is \$243 per dwelling unit.

Park Development Standards—Generally

The Village's Land Division and Subdivision ordinance also has basic standards for the improvement of parks. The Village intends use those standards, plus the following more specific standards developed by the Parks and Recreation Commission in 2013

and reproduced below, when requiring appropriate developer-installed improvements in parks to be dedicated to the Village as part of a subdivision. The Village may also use these as guidelines for the development of parks already under Village ownership. The Parks and Recreation Commission is granted flexibility in administering these standards to address unique circumstances and types of parks.

Development Standards for All Parks

All areas not designated as "natural" or "wooded" areas should have:

- 1. Soil to be deep-tilled prior to final smoothing and topsoil. Add 6 inches of topsoil fill of a good quality loamy/sandy soil not clay. Grade evenly into surrounding terrain and seed with Madison Parks turf grass mixture or other mixture identified by Village Forester or Village Engineer, and mulched.
- 2. Landscaping to include a mixture of trees and shrubs suitable to the Commission. Suggested quantities for areas within a park that are designated for future natural or passive recreational use of a park are as follows:
 - a. Climax/Canopy treesb. Medium/ornamental trees5 per acre
 - Charles (houses
 - c. Shrubs/bushes 20 per acre
- 3. All parks should have street lighting strategically located to light key areas in the park. If this is not practical, or street lighting does not reach far enough, new light standards should be installed, meeting applicable standards in the Village's Zoning Ordinance.

Development Standards for Neighborhood Playgrounds

- 1. Play area complete with:
 - a. Accessible playground equipment suitable for age group, designated by the Commission
 - b. Cushioning layer appropriate to the playground equipment
 - c. Barrier surrounding play area, designed to encompass and/or retain the cushioning layer
- 2. Open park shelter of a 16'x20' or 16'x24' area, low-maintenance style, materials, and color selected by the Commission (with dark green as default), with concrete pad extending three feet beyond eaves in all directions.
- 3. 2 heavy duty and low maintenance picnic tables, of a color, style, and type approved by the Commission.
- 4. An asphalt path or sidewalk leading from curb to shelter or other point of interest in the park. Such path or sidewalk shall be at least 6' in width, to specifications

included in the Village's Standard Specifications, and approved by the Village Engineer.

- 5. 2 park benches of a style, color, and type approved by the Commission.
- 6. Equipment setup for one or two other activities suitable for the neighborhood and selected by the Commission, such as:
 - a. Sand volleyball
 - b. Basketball
 - c. Horseshoes
 - d. Soccer goal(s)
 - e. Others that may be identified by the Commission.

Development Standards for Neighborhood Parks

- 1. For all Neighborhood Parks:
 - a. Play area complete with:
 - i. Accessible playground equipment suitable for age group, designated by the Commission.
 - ii. Cushioning layer appropriate to the playground equipment.
 - iii. Barrier surrounding play area, designed to encompass and/or retain the cushioning layer.
 - b. Park shelter of a size suitable to intended purpose of park; low-maintenance style, materials, and color selected by the Commission (dark green as default), with concrete pad extending three feet beyond eaves in all directions. Include a unisex restroom if directed by Commission.
 - c. Picnic tables of a number suitable to size of shelter and purpose of park; heavy duty, low maintenance, of a style and type approved by the Commission.
 - d. An asphalt path or sidewalk leading from curb to shelter or other point of interest in the park. Such path or sidewalk shall be at least 6' in width, to specifications included in the Village's Standard Specifications, and approved by the Village Engineer.
 - e. Park benches of a quantity, style, color, and type approved by the Commission.
 - f. Bicycle rack or inverted-U loop.
- 2. For Neighborhood Parks designated by the Commission for athletic purposes, athletic field(s) suitable to size and purpose of park, to include:

- a. Athletic field(s) landscaped, drainage installed, water (for lawns) installed
- b. Backstops/goals appropriate to the type of field
- c. Paved parking area, size to be determined by Village Zoning
 Ordinance standards and by the Commission based upon intended
 purpose of the park
- d. Optional, at discretion of the Commission:
 - i. One additional rest room.
 - ii. Bleachers or alternative seating.
 - iii. Sports equipment storage facility, generally as part of shelter.
 - iv. Additional paved paths or trails if connecting to proposed Village network.
- 3. For Neighborhood Parks and greenways designated by the Commission for primary purposes other than athletics: Requirements to be determined based upon planned use.

Chapter 7: SPECIFIC PARK & TRAIL NETWORK RECOMMENDATIONS

Future Trail Network Vision

The Village has had recent success in building off-street trails primarily for bicyclists and pedestrians, and as evidenced by community survey results additional trail development is desired by the community. Poynette also has some significant stretches of interconnected trails, particularly to and near Rowan Creek.

Over the next five years, the Village endeavors to broaden its trail development, maintenance, signage, and other improvement to develop a true *network* of trails Village-wide and to important "edge" destinations like Jamieson Park and the Mackenzie Center. The network should have both out-and-back routes plus looping opportunities. Improved connections to parks, schools, and business districts are also desired.

The Village may also consider an annual sidewalk improvement program to extend and/or complete repairs and gaps in Village sidewalk facilities.

Overview of Recommended Trails

Map 2 and Table 2 indicate trail system recommendations that, together, are intended to build the desired network. In most cases, the intent is to build new trails or paths that are off of the motor vehicle travel way of a street, and do not rely on sidewalks. These off-street trails should generally be 10 feet in width, unless constrained by available right-of-way or easement width. Asphalt or limestone, as indicated in Table 2, are the recommended surfacing options depending on the trail. In general, limestone may be used for longer and more rural routes, with asphalt advised in more developed areas.

Two different alternative routes are offered for three recommended trails on Map 2, with one for each labeled as "preferred." Each alternative recognizes that the preferred route may not be possible. These are summarized as follows:

• Trail "A" – This is the highest priority planned trail, connecting the Rowan Creek Trail system at Pine Island with Jamieson Park and its trails and growing attractions. The preferred route is through the Columbia County Sportsman League property, which the Village was negotiating to purchase at time of writing. If that land cannot be secured, then the alternative route is through the Rowan Creek Fishery Area to its north. This alternative route would require cooperation with WDNR, likely has greater wetland impacts, and as such would likely be more expensive than the cost estimate in Table 2. Map 3 presents these two alternatives for Trail "A" in greater detail.

• Trail "C" – This planned trail would connect the downtown and the eastern end of the current Rowan Creek Trail system to the middle/high school campus and

the Highway 51 business district, where a pedestrianactuated crossing current exists at the Seward Street intersection. The preferred route would include an off-street trail segment from Main Street through Veterans' Park, with users potentially going on-street on the quiet Van Buren Street (ideally with resurfacing). This route would involve a new trail crossing of the railroad along



Van Buren, in the location pictured to the right. The Village will attempt to seek approval from the railroad and/or the Department of Transportation Bureau of Rails and Harbors, as appropriate. With School District collaboration, this preferred route could then potentially wind through the school campus to the playground and the Highway 51/Seward Street intersection. The alternative route avoids the new rail crossing by heading north from the east end of Veterans' Park along the guiet Railroad Avenue, then east-northeast along existing streets, with more experienced cyclists able to use the road within a signed route and those less experienced and



pedestrians using an improved sidewalk network to get to the Highway 51/Seward Street intersection. The Washington Steet corridor is depicted above.

• Trail "G" – This proposed trail would connect the recently-constructed Highway CS trail segment and south side neighborhoods with the Rowan Creek Hatchery Trails and, in combination with Trail "A", with Jamieson Park. The preferred route follows Bluebird Circle, and then would go off-street between two lots at the west end of Bluebird Circle in the Woodland Ridge subdivision. The plat and recorded covenants for Woodland Ridge include a 15 foot wide walking trail easement in this location, and suggest that the homeowners' association was to maintain a

path in that easement. In addition to being anticipated by legal documentation, this preferred route for Trail "G" would be substantially less expensive than the alternative route. As shown on Map 2, that alternative route would continue the trail along Highway CS west to the eastern Fishery Area parking lot.

Recommended Trail Network Signage and Mapping

The Village also endeavors to better sign its trail network and make digital and hard-copy user maps available. The intent of this effort would be to better inform residents and visitors of trails, mark short on-street or sidewalk connectors where necessary, and market this growing trail amenity as a community development tool. The timing of such a signage effort may correspond with development of a major additional trail—such as Trail "A" to Jamieson Park—or with other similar expenditures such as new community wayfinding and/or park signs (described in greater detail below). As described in Table 2, this effort may include:

- Replacing existing worn Rowan Creek trailhead signs,
- Installing new trail network directional/wayfinding and/or mile marker signs (with GPS coordinates), with wayfinding signs included in places necessary to link existing off-street trails together, and
- Installing or encouraging one additional protected (signalized and/or pedestrian-actuated) crosswalk on US Highway 51 at North Street/Highway CS to provide safe, unsupervised accessibility for residents and visitors to parks, the school campus, and downtown and Highway 51 businesses.

Overview of Recommended Park Improvements

The sections that follow and Table 2 list the planned improvement projects for each existing park in the Village's system, an estimated cost for each project in 2022 dollars, and an anticipated priority for completion (1st, 2nd, or 3rd). First priority projects may begin upon adoption of this *Parks and Open Space Plan*, subject to Village Board authorization of expenditures for each listed project. Second and third priority projects are generally not anticipated for implementation until after 2023, but may be taken on sooner if unique opportunities present themselves, subject to the Village Board authorization. Such unique opportunities may include a substantial donation or receipt of a large grant.

The park improvement process will generally include:

 Annual review of community park needs and an evaluation of financial resources based with input from the Village Board, Parks and Recreation Commission, and residents.

- Validation of estimated budgets and alternative financing opportunities, including donations and grants.
- Selection of annual priorities.
- Inclusion of the priority projects in the adopted annual Village budget.
- Preparation of grant applications and detailed site, civil engineering, and architectural plans as needed.
- Notice and bidding.
- Construction authorization as needed.

Replace all existing park signs in the system (along with existing trailhead signs) is a priority of this *Plan*. These existing wooden signs are generally in poor repair and in some cases nearly illegible. More durable composite signs are advised, and are listed as 1st priority projects in Table 2. Seeking proposals for replacement of all signs at once should result in a substantial per-sign cost saving compared to replacing each sign one-by-one over time.



Jamieson Park Recommended Improvements

In 2019, the Village undertook a master planning project for the repurposing and upgrading of Jamieson Park, amended its *Park and Open Space Plan* to incorporate the master plan, and thereafter began implementing the master plan. The overall theme has been to repurpose Jamieson Park for larger footprint, nature-based or nature-compatible recreational activities. Given its location and community need, improvements have focused on teen and adult interests.

Already-completed projects have included a dog park, 9-hole disc golf course, parking lot, new pit toilet structure (late 2022), and other improvements and adjustments. Future park improvements may include expanding and adding electricity to the shelter to accommodate larger family events and possible installation of other park amenities envisioned in the 2019 master plan, possibly including a natural performance amphitheater,



aerial adventure (ropes) course, and/or bicycle pump track.

Such improvements are a lower priority, however, to the first priorities of extending a trail from the existing Village/WDNR trail system from the east to Jamieson Park, and expanding Jamieson Park to include the 76-acre Columbia County Sportsman League property to its east.

Remaining recommendations from the 2019 Jamieson Park Master Plan are included in Map 3.

This *Plan* does not advise re-introducing camping at this time. Any notion to re-introduce overnight camping would need to be balanced with the cost, maintenance, management, policing, and use compatibility particularly as other activities expand.

Pauquette Park Recommended Improvements

Pauquette Park is likely the most heavily utilized park in the Village's system, and the Village will take care not to overload it with too many additional uses. The Village will consider the following improvements to Pauquette Park through 2027:

- Replace playground equipment near the northeast corner of the park (shown to right), which is well past its recommended replacement date, has resulted in minor injuries, and parts for needed repairs are generally no longer available.
- Install taller fences beyond foul lines at southwest ball field.
- If funding permits, such as via a tax incremental district pending at time of writing, complete more extensive park improvements perhaps including parking lot reconfiguration and stormwater management improvements, a pavilion to better host community events and food trucks, spectator improvement at ballfields like bleachers and/or shade structures, alternative energy improvements, and others.
- Install accessible fishing pier/spot along Rowan Creek, either on south or north bank. This final improvement may extend beyond the five-year period.

Valley View Park Recommended Improvements

The Village does not intend to make major improvements to this park in the five-year *Plan* period, except for replacement of the two park entrance signs. The Village envisions a new tee ball field on the County easement land, and may work with the County to acquire that land, but this will not occur until the County land is appropriately



remediated. The Village will also be careful not to overuse existing field space at Valley View Park.

Veterans' Memorial Park Recommended Improvements

The Village may extend a path along Rowan Creek through Veterans' Park and replace the aging park sign, as described elsewhere in this chapter. The Village also anticipates supporting community garden upgrades at the east edge of Veterans' Memorial Park. This may include a new or relocated storage shed, new gardening equipment, greenhouse enhancements, and/or other improvements in concert with the Poynette Area Gardening Association. Finally, Veterans' Park may serve as an appropriate permanent home for the Village's ice skating rinks.



Old Settlers' Park Recommended Improvements

South of Rowan Creek, Poynette has close to 700 residents. Old Settlers' Park is the only Village park in the developed part of Poynette south of Rowan Creek; further, none of the Poynette School District playgrounds and fields are south of the Creek. Old Settlers' Park also has some of the oldest recreational equipment in the Village's parks system. On the plus side, Old Settlers' Park has interesting topography and history, is walkable from most of the Village's south side, and was recently better connected to the rest of the community via a trail project.

Through this *Park and Open Space Plan*, the Village advises preparation of a park revitalization master plan for Old Settlers' Park. This is similar to the treatment for Jamieson Park in 2019, before recent improvements there were commenced. Given

the close proximity of residential neighbors, community involvement should be a component of this planning process.

Table 2 lists some preliminary improvement ideas to be explored during a master planning process for Old Setters' Park, but that separate process would guide actual recommended improvements. In any case, the historic significance of Old Setters' Park—as described earlier in this *Plan*—should be a key factor in the master planning and eventual improvements to Old Settlers' Park.

Colby Park Recommended Improvements

Colby Park has been undeveloped since it was dedicated with the adjacent subdivision many years ago. It enjoys abundant sunlight, is accessible to the neighborhood, and would become more accessible with the planned trail extension to it through the greenway from the south (see Map 2). It is also relatively close to active-use recreational facilities in Valley View Park and at the Poynette Elementary School site.

The above conditions suggest different future recreational opportunities in Colby Park than are typical of neighborhood parks and playgrounds in Poynette. The recommended improvement program includes a natural playground, defined as an area bult entirely or predominantly from natural materials like boulders and logs for children's recreation (see example to right), plus a prairie or oak savannah



restoration area with wildflowers and walking paths that may be more appealing to adults. A fruit tree orchard is also possible. The concept would be to minimize costs that are otherwise typically associated with constructed play equipment, and to lean on volunteers for installation and maintenance—potentially including the Gardening Association if interested.

Columbia Park Recommended Improvements

No major improvement projects are envisioned for Columbia Park over the five-year *Plan* term. The worn park sign should be replaced in conjunction with the recommended Village-wide effort described above, with perhaps a second sign at the Eagle Lane entrance also installed.

South Park Recommended Improvements

Based on a recommendation of the prior *Park and Open Space Plan*, the Village had investigated the possible disposition of South Park but found the legal and cost hurdles to be not worth the effort.

The most likely future for South Park during the five-year term of this *Plan* will be to leave it as-is and monitor its current usage patterns. Natural area restoration or a fruit orchard are also possible, particularly if one or the other is not implemented in Colby Park. Any such improvement may be combined with marking the public access easement from Highway CS through the West Hill First Addition subdivision.



If and when adjacent lands south of South Park along Highway Q develop or come available, the Village may consider park expansion to the south of the current park limits. This would expand the size of this small park, potentially make the shape more regular, and also make it more accessible to the community.


Northwest Neighborhood Park Recommended Improvements

In spring 2022, a developer brought forward a plan to replat the unimproved West Ridge subdivision, platted in the mid-2000s at the northwest corner of the Village. At time of writing, the Village was establishing incentive, zoning, and plat approval structure to advance that residential development. As envisioned, the replat would include over 450 single- and multiple-family housing units, perhaps developed over a decade.

The replat also anticipates up to 9.5 acres of public parkland, mainly near the center of this 80-acre site. Ideally, this would replace the two existing small parks originally dedicate with the West Ridge plat. In conjunction with this anticipated park dedication, the Village and Parks and Recreation Commission would likely guide a park master planning process to determine the range of appropriate recreational improvements, likely in conjunction with the developer. Village park improvement fees may be used, at least in part, to fund park improvements.




Q1 How often do members of your household visit Poynette's Village parks?




