I hereby pledge to provide positive support, care, and encouragement for my child and their team by following this Code of Ethics:

- I will do my very best to make youth sports fun for my child.
- I will ask my child to treat other players, coaches, fans, and officials with respect at all times.

Failure to comply will result in disciplinary actions being taken to resolve the issue. Actions may include but are not limited to verbal warnings and or suspensions. Incidents will be handled how staff deems appropriate based on the severity of the incident.
