EXCLUSIONS OF SCHOLARSHIP:

* Any late fees associated with registration

SCHOLARSHIP CONTRIBUTION: * Max of \$70 per program

* Max of 2 programs per child per year

* A \$280 maximum scholarship per family per year * Scholarships are granted on a funds-available basis

APPLICATION PROCESS:

* All scholarship requests must be on the official scholarship form.
The application must be signed by the parent/guardian. Applications must be completely filled out to be considered for the scholarship.

* All applications must be a puritient request for United May.

* All applications must have a written request for United Way scholarship funds.

* Parents or guardians of school-age children can provide proof of current enrollment in a school lunch assistance program in order to assist in the evaluation process.

* Parents or guardians of pre-school age or younger children can use a current enrollment in a school lunch assistance program for an older sibling, documentation of food stamps or proof of enrollment in Medicaid, etc.

* Once the application is received, requests will be reviewed and the applicants will be notified. *Incomplete applications will not be accepted.* Submittal of an application does not guarantee the applicant a scholarship grant.

APPLICATION DEADLINE:

* Completed applications MUST be turned in 2 weeks before the registration closure of the respective sports seasons. Applicants will be notified within 5-8 business days after the application is received and must register before the registration end date of the respective sports season or event.

* This scholarship is valid for programs that start between January 1, 2025 and December 31, 2025 (or once funds have been exhausted).
