## 2025/2026 Parental/Guardian Permission and Waiver

1. **PERMISSION:** I am the parent or legal guardian of the above-named participant. I acknowledge that my child is in good health. I give permission for my child to participate in any Wranglers activity, including transportation to and from the activity. I give permission for, and assume any and all risk of my child's use of various playing surfaces including natural and artificial grass, cheer mats, hard dirt, and under varying conditions, including, dry, wet and muddy, and I hereby understand that any surface may be regular or irregular.

2. **RISK INFORMATION:** I acknowledge the inherent risk and danger of participation in any sport and I understand that participation in football, baseball, cheerleading and/or dance may result in BODILY INJURY, PARALYSIS, BRAIN INJURY, PERMANENT DISABILITY AND/OR DEATH. I acknowledge that protective equipment does not prevent all participant injuries. I release, indemnify, hold harmless and waive any claim against the coaches, local, league and the Wranglers, and any and all organizers, sponsors, supervisors, participants, and persons transporting my child to and from activities, for any injury to my child whether the result of negligence or for any other cause.

3. **EMERGENCY MEDICAL AUTHORIZATION:** I give permission for emergency medical/dental treatment or first aid to be administered to my child for any illness/injury/accident resulting from participation in Wranglers activities.

4. **EQUIPMENT RESPONSIBILITY:** I acknowledge my responsibility for any and all equipment/uniforms loaned to my child and I agree to promptly return, upon request, the uniform and other equipment in good condition except for normal wear and tear. If I fail to comply, I will be responsible for the cost of such equipment/uniform.

**5. INSURANCE DISCLOSURE:** I am aware that the Wranglers carries group accident medical insurance which is secondary or excess to my insurance which is considered primary insurance. Further, I agree to notify in writing my head coach and the Wranglers organization of any medical claim from participation as soon as reasonably possible. I understand that the registration fee is not premium for insurance and that deductibles may apply.

**6. SCHOLASTIC FITNESS:** I confirm that my child is scholastically fit and will work hard to maintain good grades during the season. Further, I authorize the Wranglers access to all grades and report cards if necessary to make sure scholastic needs are being met first and foremost.

**7. FINANCIAL RESPONSIBILITY:** I acknowledge that my rights, if any, to a refund depends on the Wranglers Organization policies, and I have also been advised of my fundraising obligations for the entire season and agree to fully comply with those obligations.

**8. COMMUNICATIONS, PROMOTIONS, AND CONSENT:** As a condition to my child's participation, I consent to receive communications by email and mail from Wranglers and its sponsors. I understand the Wranglers does not sell its contact list. Communications may contain program information or special offers. Further, I grant the Wranglers the right and permission to make, reproduce, broadcast or otherwise use in perpetuity my child's name and likeness including photograph, films, videos, recordings, or other depictions or images in any form or media throughout the universe, for promotional material, advertising, editorial, trade or other purpose. To the extent that any benefit may accrue therefrom, I forever waive any interest in or claim to such benefit and acknowledge that the Wranglers is under no obligation to exercise any rights granted herein.

**9. ADULT CODE OF CONDUCT:** S1: In order to uphold the goals of the Wranglers and ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardians and other adults and attendees of Wranglers events, including but not limited to practices, competitions, and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times. S2: Any adult who is using alcohol, tobacco or nonprescription drugs and/or appears intoxicated at a Wranglers event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave the event. The member organization may also provide a written warning to the individual regarding the misbehavior. The adult's children may also be removed from the event. Any adult who commits one of the above stated offenses a second time, will be banned from any and all Wranglers events for a period of one year from the date of the second offense, and their children may also be removed from the program(s) for that time period. S3: Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens grave bodily harm may be banned from any and all Wranglers events for one year from the date of the offense, and their children may also be removed from any and all Wranglers programs for that same period of time. After the ban has expired, if the individual commits another offense of the adult code of conduct, the individual will be permanently banned from any and all Wranglers events and the individual's children may also be permanently removed from any and all Wranglers programs.

**10. ADHERENCE TO ELBERT COUNTY WRANGLER RULES AND PROCEDURES:** I understand that it is my responsibility to comply with all rules and regulations of the Wranglers and its affiliated organizations (Arapahoe Youth League, Gold Crown, Peak2Peak, etc) and understand that non-compliance may be cause for discipline and/or dismissal of my child, myself, and/or other persons affiliated with me or my child. I agree to furnish an authentic certified copy of my child's birth certificate to Wranglers officials and understand that valid proof of age, a current calendar year's signed medical release, scholastic fitness form and this form must be presented before any official Wranglers activities. I hereby hold the Wranglers harmless of any financial loss as the result of any disciplinary action.

**11. FINANCIAL RESPONSIBILITY FOR FINES:** I acknowledge that if I, my child, or any individual in my party in attendance at any Wranglers activity violates either the Adult Code of Conduct and/or Player Code of Conduct as outlined in the Arapahoe Youth League guidelines (or other leagues we associate with per sport) that results in assessment of a fine by the Wranglers organization or league, that I am financially responsible to the Wranglers for any such fine. I also acknowledge that future attendance or participation in any Wranglers activities will be suspended until such fine is paid, and that multiple violations could result in additional disciplinary actions including but not limited to banning from all Wranglers activities.
